Disabling the Church is a podcast that amplifies the voices, giftedness, and perspectives of disabled people, challenging ableist biases and reimagining the church as a space of true belonging. Through conversations with scholars, ministers, and community members, the podcast explores how the church can dismantle barriers—physical, theological, and cultural—to create a more inclusive and enriched faith community.

- Practice of Counsel and Care (both in person & online):

In this introductory course, students explore giving counsel and offering care as ministers of Word and sacrament. They develop an understanding of the fundamental principles of pastoral care and acquire basic skills required for giving counsel and offering care. Numerous pastoral themes are addressed in lectures, learning labs, and small group interaction. Students will be encouraged to develop their own pastoral presence in offering counsel and care.

- The Bible, Disability, and the Pastoral Imagination:

What do people with disabilities find when they try to find themselves in our biblical texts? This course addresses some of the issues, hermeneutical and pastoral, that people with disabilities encounter when reading the Bible. The class will read interpretative texts written by persons with a variety of disabilities and consider how their insights can support our pastoral imagination.

- Living Into Community:

In this course, students spent time critically reflecting upon what it meant to live into community as an act of mutual discipleship. Students engaged questions such as: What is discipleship? What is a Christian community? What is the difference between a Christian community and a social group? What does it mean to belong to, rather than simply be included in, a Christian community? What are communities for? And, what should communities (and their members) do? These questions were engaged alongside a detailed consideration of how 'community' is expressed within the seminary community through the Friendship House Community, the classroom, the daily fellowship offered within the community kitchen, and the sacramental praxis of daily chapel worship.

Henri Nouwen Doctoral Fellow: I have been given the opportunity to teach one course per term in conjunction with my role as the Resident Director of the Friendship House. This is a temporary faculty post awarded to two (ABD) early career scholars and intended to be held as they complete the final stages of writing and defending their Doctoral dissertations.

- *Friendship House Fellows Program*

My time as a Doctoral Fellow also included coordinating the curriculum design of, student recruitment for, directing, and launching the Friendship House Fellows program. This program allows individuals who live with intellectual disabilities to enroll in seminary as students in a non-credit bearing certificate program. Through the launching of this program, the Friendship House has moved beyond simply being a place where people with intellectual disabilities live alongside students of theological education. Instead, the Friendship House has become an intentional living community where all the

members—able-bodied and those with disabilities, alike—are recipients of (and participants in) theological education, spiritual formation, and vocational discernment. The Friendship House Fellows Program launched in the Fall-term of 2020.
